### SUMMARY OF TESTING METHODS AND KEY FINDINGS

The overall approach of the real-world testing plan for Azara DRVS focused on assessing the usage of clinical quality measures as implemented and certified for the module *Clinical quality measures (CQMs) — report*. Azara DRVS is marketed to be used in any setting with access to an internet browser by multiple types of organizations. Testing methods measured the overall usage of the certified CQMs by categories of users over the measurement year. Testing returned rates of usage by different user types.

Measure results showing no usage by all user types would be a scenario that indicates a technical failure of the product to provide access to users to the certified CQM reports. *No situations of zero usage for a user were discovered during the 2024 testing*
